## Terms and Conditions of SCOW Membership

In consideration for being allowed to participate in sailing or other activities (the "Activities") conducted by the Sailing Club of Washington ("SCOW") including, without limitation, sailing Activities on or with property (the "Property") made available by SCOW or SCOW members, I, the undersigned, for myself, my heirs and next of kin, representatives and assigns (collectively, the "Releasing Parties"), fully, freely, voluntarily and forever discharge and covenant not to sue, and therefore **release and indemnify**, SCOW and its respective affiliates, owners, directors, officers, employees, members and agents and their respective successors and assigns (collectively, the "SCOW Parties") **of and from any and all claims**, causes of action, demands, damages, costs, loss of services, expenses, compensation, all consequential damages and attorneys' fees (regardless whether pursuant to the laws of any county, state or country) **on account of**, or in any way arising out of or relating to, directly or indirectly, any and all known and unknown **injuries, death, and property damage arising out of**, relating to, or resulting, directly or indirectly, from the **Activities regardless of the cause** and without regard to any and all conditions, known or unknown, then existing or which may develop, on or related to the Property or negligence (including, without limitation, gross negligence and dangerous or defective equipment owned, controlled or maintained by the SCOW Parties) by or on behalf of any SCOW Party (including all injuries, deaths, paralysis and conditions of health, whether or not immediately apparent following the Activities, or which I may at any time thereafter develop, collectively, "Liabilities").

I understand, acknowledge, and agree that (1) I am participating in the Activities voluntarily, (2) the Activities may be or become dangerous and may result in serious bodily injury, paralysis and/or loss of life to myself or others, (3) I may be photographed or videographed at SCOW events, that these images may appear in club-related materials in which I may be identified by name and (4) by signing this Agreement, for myself and on behalf of the other Releasing Parties, I am releasing certain substantial rights and I agree with all the terms listed above. I HEREBY PERSONALLY ASSUME ANY AND ALL RISKS in connection with any and all activities in which I will participate.

I expressly acknowledge and agree that the release of liability contained in these Terms and Conditions of SCOW Membership ("Agreement") is intended to be as broad and inclusive as permitted by applicable law and that if any portion hereof is held invalid by a court of competent jurisdiction, it is agreed that the balance of this Agreement shall continue in full legal force and effect. I hereby warrant and represent that I am 18 years old or older, that I have carefully read this Agreement, that before signing I was able to ask questions, and that I agree to its Terms and Conditions.
