

Waiver of Liability Relating to Coronavirus/COVID-19

It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize SCOW's boats and/or attend a club function you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

I am aware that there is a risk of contracting, being exposed to, contracting, and/or spreading COVID-19 in the use of club boats in person and by signing this waiver, I personally assume those risks. I waive any and all claims for damages or restitution in any form for injury or damage to persons or property sustained from any cause whatsoever in connection with any activities sponsored or conducted by the SCOW, including any use of its vessels. I further relinquish all rights that I or anyone acting on my behalf may have to make any claim or pursue legal action of any sort against the SCOW, its officers and directors, or any of its members when acting in their club capacity, in relation to any damage or injury sustained from any cause whatsoever, including negligence, in connection with any activities sponsored or conducted by the SCOW, including any of use its vessels.

I have not experienced any COVID-19 symptoms in the last 14 days.

I have not been in close contact with anyone who has exhibited signs or symptoms of COVID-19 in the last 14 days.

I have not been in close contact with anyone who has tested positive for COVID-19 in the last 14 days.

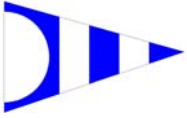
